Welcome to the CHAP IPC

The CHAP IPC (Interactive Public Calendar) is an optional calendar tool which displays court hearing and 341 meeting calendars in a simple, user-friendly interface. The IPC features are similar to the ChapMobile App toolset in a simplified interface.

Features:

- Search Hearing and 341 Meeting Calendars by date, attorney, debtor, case number, and judge
- · View and download Hearing and 341 Meeting calendars
- Filter Hearing calendar data to display only selected chapters or case types
- Generate and download Hearing and 341 Meeting calendars from a mobile device or from a website
- · Select one of three color themes
- Attorneys can generate and download their own personal Hearing and 341 Meeting calendars

Attorney Search:

Select **ATTORNEY SEARCH** or the **Q** icon to search for hearings by an attorney name. The following screen opens with each letter of the alphabet to search for an attorney by their last name. Enter an attorney's name in the field at the top of the screen or select a letter of the alphabet (the following example shows the letter "A") to search for an attorney by last name.

Note: The on indicates the attorney has active hearings.



When an attorney has an active hearing, select their name to open the following screen. This example shows the Hearing Calendar for Lewis Adams. From this screen, view the active hearings for the attorney:



- Select the **I** icon to print the report.
- Select the icon to navigate back to the Hearing Calendar.
